All India Institute of Medical Sciences (AIIMS), Awantipora (J&K), is being established as an Institute of National Importance & is one of the newly upcoming AIIMS and apex healthcare Institute under the Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) which has been established by the Ministry of Health and Family Welfare, Govt. of India, with the aim of correcting regional imbalance in quality tertiary level healthcare in the country, and attaining self-sufficiency in graduate, postgraduate and higher medical education and training. 1. Applicants satisfying the eligibility criteria in all respect can submit their application only through ON-LINE mode. The Online applications can be done through the website [www.aiimsexams.ac.in](http://www.aiimsexams.ac.in) **20/05/2026 to 18/06/2026 till 5:00 P.M.** of closing dates as specified in this advertisement. No documents, including the Registration Slip of the online application form, are required to be sent in Physical form. All the applicants are advised to keep a copy of the registration slips with them, along with proof of payment, for their records.
2. Correction in registration details will not be considered through any mode i.e. Email/letter. Hence candidates are advised to fill their registration form carefully as no correction will be allowed after online submission of the form.
3. The candidature of applicants who fail to complete the online application by the stipulated date and time will not be considered. No correspondence in this regard will be entertained.
4. Those applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must fulfill all the eligibility criteria as on or before the closing date of online submission of applications. Required educational qualification/ experience should be completed on or before the last date of the online submission of the application. In the case of educational qualification, the candidate should have completed the residency period for the desired educational qualification as well as have been declared successful in the final examination, on or before the last date of online application submission. Likewise, the candidate must have completed the duration of desired experience wherever applicable on or before the cut-off date, i.e. last date of submission of the online application.

5. Applicant may apply for more than one post code if they meet the eligibility criteria for the post/s.
6. Cut-off date to determine eligibility in terms of the age of candidates will be the last date for Online submission of applications.
7. All applicant must note that ***it is assumed that you are in possession of all required certificates to substantiate your eligibility on the day of the online application/day by which is required to be submitted at the Institute as per validity published in this notice. These include category certificate/ employer NOC, certificates of education qualification and experiences as applicable, Candidates will submit these as and when asked for.***
8. The mode of Selection will be interview & the schedule of the interviews will be uploaded on the Institute website at least two weeks in advance.
9. **List of shortlisted candidates who are eligible to be called for interview will be uploaded on the website. Candidate/s should keep on visiting website for updated information.** They should make necessary arrangements for attending the interview as per the given schedule.
10. The interview dates uploaded on the Institute's website will normally remain unchanged. However, if due to any unforeseen circumstances, there is a change, this will be notified on the AIIMS website.
11. All communication will be made through your MyPage, Email and SMS. No physical letter will be sent for any activity related to this recruitment.
12. Candidates are **not to send physical copies** of application form/document. All correspondence related to this recruitment should be made via e mail.
13. If only UR posts are available, candidates of any category can apply (provided they meet the age criterion and experience criterion as applicable to UR candidates).
14. Unfilled EWS Posts: If there is/are no eligible or suitable candidate from the EWS category for any of these post/s, such EWS post/s will not be carried forward as backlog vacancies. These will be filled as Unreserved (UR) posts. Candidates who are otherwise eligible to apply for UR post (including those from reserved categories), can apply for EWS posts.
15. Application Fee: The application fee paid by these candidates to apply for EWS posts will not be refunded under any circumstances.
16. In accordance with Government of India guidelines, 4% of posts are reserved to persons with Benchmark disabilities (PWBD).
17. For positions mandating prior experience, the experience should have been acquired after successfully completing the essential qualification specified in the Recruitment Rules for the respective post. Moreover, the desired duration of experience must have been completed on or before the last date of online application.
18. Required teaching/research experience should have been acquired from an institution recognized by NMC/MCI/DCI/Indian Nursing Council/State Nursing Council or UGC as applicable. For any experience to be considered valid other than these, the Screening Committee's decision will be final.

The Institute will use a set of objective criteria for short listing candidates to be called for interview for this recruitment (Copy of objective criteria is enclosed): -

All prospective candidates should go through these criteria before submission of online application for the post/s.

(i) Stage 1 of Screening: All applications meeting the age criteria, essential educational qualifications and experience requirements for the post will be shortlisted in first stage.

(ii) Screening and Short-listing of applicants: Further screening using objective criteria will be done in those cases where the number of valid applicants after 1<sup>st</sup> stage screening for any one post is more than ten.

iii) Mandatory Supporting Documents: Candidates must upload supportive documents as proof of meeting the criteria which they have filled in online application. Failure to upload supportive documents will result in scoring for that criteria to be NIL.

iv) Based on information provided & supportive documents provided for various criteria, each candidate will be assigned a score. All applicants will be ranked as per total score and candidates scoring top 10 score for each post (if more than one post is there, multiple of ten scores will be used for e.g. – for 02 posts, 20 top scores and so on) will be shortlisted. If more than 1 candidates have same score, they will be shortlisted even if the total no. of shortlisted candidates exceeded 10 or multiple of 10.

v) **Screen score will be used for short listing of candidates to be called for interview only.**

vi) Final selection of candidates who are shortlisted and called for interview, will be based on the assessment of Standing Selection Committee of the candidates during the interview.
