The Walk-in Interview for the month of May will be held on 18/May/2026**If the third Thursday of the month falls on a public holiday, the interview will be conducted on the next working day.**

1. This is a rolling advertisement and will be applicable for filling up the vacancies notified above, as well as unfilled/fresh posts, through subsequent amendment notifications published on the ESIC website (www.esic.gov.in/recruitments). The advertisement will remain valid up to 31/12/2026 or until the issuance of a closure notice, whichever is earlier, without the need for re-publication. Walk-in interviews will be conducted accordingly for eligible posts, subject to the availability of vacancies on the date of interview. The updated list of vacancies will be published at the end of every month after the conduct of the walk-in interview.
2. Aspiring applicants satisfying the eligibility criteria in all respects may appear for the walk-in interview on the scheduled dates. However, a candidate may appear for the interview only once in a month.
3. Applicants applying in response to this advertisement should ensure that they fulfill the eligibility criteria for the post applied for. They must satisfy all eligibility conditions as on the date of interview.

Note:-

In case no candidate is available for engagement in a particular reserved category in a specific specialty, the available suitable candidate(s) in the respective specialty may be engaged for a period of 44 days at the sole discretion of ESIC.

ESIC Hospital Udaipur, provides health care services to insured persons and their dependents belonging to the grass root level of society. To ensure uninterrupted availability of essential specialized medical services, if no candidate is available for specialist posts earmarked for the EWS category, such posts may be filled by available eligible candidates on merit basis as Part-Time/Full Time Specialists and Senior Residents (for a maximum tenure of one year or up to, whichever is earlier) in the concerned discipline.

Important Instructions :-

1. **All candidates are required to appear for document verification along with the duly filled-in Application Form (as attached) within the scheduled time (09:00 AM – 11:00 AM). No candidate will be allowed to attend document verification after 11:00 AM on any of the scheduled dates mentioned above.**

3. Reservation of posts shall be applicable as per the Government of India guidelines

ELIGIBILITY CRITERIA FOR THE POST OF FULL TIME/ PART TIME SPECIALIST

Upper age limit: 67 years as on the date of interview.

(Relaxation for SC/ST/OBC/EWS as per rules: SC/ST – 5 years; OBC (Non-Creamy Layer) – 3 years; PwBD (UR) – 10 years; PwBD (OBC) – 13 years; PwBD (SC/ST) – 15 years. Ex-Servicemen: as per Govt. of India rules. Age relaxation for EWS candidates is not applicable as per extant guidelines.)

Essential Qualifications:

- i) MBBS degree along with MD/MS/DNB or Postgraduate Diploma in the concerned specialty from a Medical College/Institution recognized by MCI/NMC.**
- ii) Must be registered with MCI/NMC or the State Medical Council.**
- iii) Minimum of 3 year’s experience after acquiring PG Degree OR minimum of 5 year’s experience in the concerned specialty after acquiring Diploma.**

Note:-

Candidates with at least 5 years of post-specialty qualification experience will be considered for engagement as Consultant (Senior Level).

The additional hour of work will be decided by the MS. No other allowances in any form shall be admissible.

ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS

Upper age limit: 45 years as on the date of interview.

(Relaxation for SC/ST/OBC/EWS as per rules: SC/ST – 5 years; OBC (Non-Creamy Layer) – 3 years; PwBD (UR) – 10 years; PwBD (OBC) – 13 years; PwBD (SC/ST) – 15 years. Ex-Servicemen: as per Govt. of India rules.)

Essential Qualifications:

- i) MBBS with PG Degree / Diploma in concerned specialization from MCI/NMC recognized Medical College/Institution.
- ii) Must be registered with MCI/NMC or the State Medical Council.

For Senior Residents :- Basic Pay Rs.67,700/- in Level 11 and other allowances (NPA, DA, HRA, TA...etc) as per 7th CPC and ESIC Hqrs instructions. Further any changes in regard to remuneration/others shall be applicable as per ESIC Hqrs. amendment/direction from time to time.

Terms & Conditions for Full-Time / Part-Time Specialist:-

A) Full-Time Specialist

The engagement will be for a minimum period of one year or until a regular incumbent joins, whichever is earlier. The contract may be extended annually based on satisfactory performance.

B) Part-Time Specialist

The engagement will be for a period of one year or until a regular incumbent joins, whichever is earlier.

C) Private Practice

Full time Specialist engaged on a full-time basis will not be permitted to undertake any form of private practice.

D) Age Limit

In the case of selection, engagement for both Full-Time and Part-Time Specialists will be up to the age of 67 years or the contracted period, whichever is earlier.

E) Availability

The Full time Specialist shall be available on call 24x7 and Part time Specialist available on call 24x7 if he/she is drawing emergency call charges.

F) Responsibility

The Specialist shall be responsible for all patients undergoing treatment under his/her supervision in the respective speciality.

G) Professional Indemnity Policy

The selected Specialist must hold a valid professional indemnity policy covering the entire period of contractual engagement. The policy shall provide protection against professional liability arising from errors or omissions committed while rendering professional services. The minimum sum assured per annum shall be as follows:

₹30 lakhs – for Anesthesiologists, Cardiac Surgeons, Neurosurgeons, Plastic Surgeons, etc.

₹20 lakhs – for General Surgeons, Gynecologists, Obstetricians, etc.

₹10 lakhs – for Physicians, Dentists, Radiologists, Pathologists, etc.

A copy of the insurance policy along with the premium payment receipt must be submitted within 7 days from the date of engagement.

H) Regularization

Selected candidates will not claim for regularization of their service in the hospital/ESIC or nor they will claim for any service benefit like, PF, Pension, Gratuity, medical Allowance, Seniority, and Promotion etc. This condition must be submitted in the form of an affidavit at the time of joining.

I) Leave Entitlement- Full-Time Specialist

A Full-Time Specialist shall be entitled to leave at the rate of 4 days for each month of service on a pro-rata basis in a calendar year. In the event that the Specialist chooses not to avail the leave, the same may be encashed, subject to a maximum limit of 30 days.

J) Leave Entitlement- Part-Time Specialist

A Part-Time Super Specialist shall not be entitled to any leave benefits.

K) Medical Fitness

The appointment is subject to the candidate being declared medically fit.

L) Travel Allowance

No TA/DA shall be admissible for attending the interview or for joining the post.

M) Acceptance of Offer

The selected Full-Time/Part-Time Specialist shall be required to submit a written acceptance / consent letter prior to undergoing the medical examination.

N) Termination/ Resignation

The appointing authority reserves the right to terminate the engagement at any time, even before completion of the tenure, without assigning any reason, by giving one month's notice. Similarly, the engaged Specialist shall be required to give one month's prior notice before resignation or, in lieu thereof, pay an amount equivalent to one month's remuneration.

O) Reserved Category Certificates

Candidates applying under OBC/SC/ST/EWS/PwD categories must possess a valid certificate issued by the competent authority for admission/employment in Central Government Institutions. The certificate must be issued before the date of the interview.

Failing this, the candidate will not be allowed to appear under the reserved category, although he/she may be considered as an Unreserved (UR) candidate.

P) OBC (Non-Creamy Layer) Reservation

No request or correspondence in this regard shall be entertained.

Q) PwD Reservation

Candidates engaged under the PwD quota will be adjusted against the vacancies of their respective categories (SC/ST/OBC/UR). The disability certificate must be issued by a duly constituted and authorized Medical Board of a State or Central Government Hospital/Institution.

R) EWS Reservation

EWS candidates must produce an EWS certificate in the prescribed Government format (as per DoPT O.M. No. 36039/1/2019-Estt.(Res.) dated 31.01.2019 and revised format issued vide O.M. dated 17.07.2023), valid on the date of interview. The certificate must be issued by a competent authority (Sub-Divisional Magistrate / District Collector / Tehsildar as authorized by the State Government).

S) Misconduct/ Negligence

If any doctor is found guilty of gross misconduct or negligence of duty, his/her services shall be terminated immediately, without notice or payment in lieu of notice.

T) Joining

Selected candidates shall join duty immediately or on the date specified in the offer of appointment/engagement. Failure to do so will result in cancellation of the offer letter.

U) Dress Code

Full-Time/Part-Time Specialists/Senior Residents shall wear their own white coat with a name badge during duty hours.

V) Attendance

Attendance shall be recorded both manually and through the AEBAS (Aadhaar Enabled Biometric Attendance System).
